After the assessment, completed a consent form and underwent a mapping session. This involves taking scalp measurements to locate the correct treatment location, as well as calculating a personalised baseline motor threshold for TMS treatment. There were no issues with the mapping session, and a schedule of appointments have been made to initiate treatment shortly.

Thank you for referring Garrad to be assessed for TMS treatment. attended the assessment today and they were able to provide a history of their symptoms and mental health.
Based on today's assessment, I felt he has had a partial response to his previous TMS treatment whilst he was admitted at South Coast Private Hospital back in February to March 2023. reported that he had a further course of TMS treatments at South Coast Private Hospital later in 2023 but found these were not as reffective due to circumstances with other in-patients. provided a detailed account of his past mental health history which included use of alcohol and other drugs including marijuana, methamphetamine, heroin and psychedelics.
has informed us that his alcohol intake is currently characterised by several binge day during the week During the assessment we discussed that the consumption of large amounts of alcohol prior to having TMS creatment can increase the level of risk for a seizure to occur and as such we discussed our recommendations of no alcohol for 48 hours prior to treatment. Understood this and advised that this would not be an issue.
Furthermore has reported to us that on 3 occasions an attempt at suicide in 2013 and 2014 were made During today's assessment has reported to us that they are currently not on any regular medication nowever, did mention that they wish to recommence on Largactil 50mg nocte to help them sleep. Based on today's assessment, I felt that they meet the Medicare criteria for rebatable TMS treatment. I am also satisfied that there are no apparent contraindications for the TMS treatment.
